In KA1 the number of applications decreased from 551 in 2018 to 453 in 2019, consequence of the first year without volunteering projects.

The action registered 40% of newcomers in 2019 and the average score of projects approved under KA1 was 82,0 points, compared to 78,2 points, in 2018.

Nevertheless, only 27% of applications were approved, due to the lack of funds available to support all the quality projects submitted to the PT02NA. However, we would like to stress that 407 submitted applications had the required quality to be approved out of the total of 435.

In KA1 the number of projects approved were: 88 Youth Exchanges and 41 Youth Workers Mobilities.

Analysing the objectives, priorities and topics addressed in the applications and in the granted projects, we can notice that Inclusion – equity – was the leading topic in KA1, addressed in 39,3% of the applications and 42,3% of the granted projects. Youth (Participation, Youth Work, Youth Policy) ranks second, representing 37,5% of the applications and 34,1% of the approved projects. Creativity and culture come in third place in the applications, being addressed in 23,9% of the proposals submitted, while recorded in 23,6% of the granted projects. These topics are followed by Civic engagement / responsible citizenship; Entrepreneurial learning - entrepreneurship education; Environment and climate change; EU Citizenship, EU awareness and Democracy.

It is worth mentioning that 6 projects were approved in the ultraperipheral Portuguese regions (the autonomous regions of Azores and Madeira).

b. Key Action 2 (KA205)

The number of applications submitted has increased (more 4 applications in total compared to 2018) as did the quality of the approved projects.

The average score of projects approved in KA2 was 79,4 points, comparing to 76,6 points in 2018. The average score of the submitted applications in KA2 was 69,1 points, comparing to 69,7 points in 2018. Only 16% of applications were approved, due to the lack of funds available to support all the quality projects submitted to the PT02NA. 55 submitted applications had the required quality to be approved out of the total of 68.

The approval rate in this Key Action is dramatically low and the increase of funds from one year to the other does not meet the expectations that the presentation of Erasmus + 2014 - 2020 created.

We can notice an interesting diversity in the type of organizations that apply, such as municipalities, youth organizations, NGO's and foundations working in the youth field.

In KA2, the topic Participation, Youth Work, Youth Policy comes in first place, being addressed in 63,2% of the applications and 45,5% of the granted projects. ICT - new technologies - digital competences comes in second place, present in 35,3% of the applications and 36,4% of the approved projects, followed by Inclusion - equity, addressed in 29,4% of the submitted applications and recorded in 27,3% of the granted projects.

c. Key Action 3 (KA347)

The number of applications submitted to KA3 has remained at 24 in 2019.

The average score of projects approved in KA3 was 74.5 points, compared to 76.0 points in 2018.

Only 21% of the overall applications were approved due to the lack of funds available to support all the quality projects submitted to the PT02NA. 21 submitted applications had the required quality to be approved out of the total of 24 (I.3.8.3).

As regards to KA3, Youth (Participation, Youth Work, Youth Policy) comes in first place, being addressed in 70,8 % of the applications and 80,0 % of the granted projects.

EU Citizenship, EU awareness and Democracy is covered in 62,5 % of the applications and 80,0 % of the granted projects, followed by Reaching the policy level/dialogue with decision makers,—addressed in 54,2 % of the applications and 80,0 % of the approved projects.

Overall, we achieved the goals set out for 2019. The number in KA1 clearly exceeded the goals set for 2019.

The percentage of YPWFO participating in KA3 projects exceeded the target (I.3.6.2), however, the share of awarded projects with topics related to inclusion of people with fewer opportunities is slightly below the target (I.3.6.3). In half of the approved projects, topics related to the inclusion of young people with few opportunities are addressed, however, the percentage is below the target set (I.3.6.2). The reduced number of granted projects helps to justify this percentage fluctuation.

We implemented several information sessions where on YPWFO.

Regarding cross sectorial projects, it has always been difficult to measure this indicator because, in some cases, the projects address horizontal priorities that are not identified in the applications. I.3.5.1 - involvement of participants in projects with neighbouring partner countries- we managed to exceed the initial target of 650 by 224 participants. Although we have tried to engage organisations that are willing to work with YP with special needs, through tailor designed trainings and activities there are very few organisations willing to involve this target group or with capacity to do so. This is reflected in the low number of awarded KA1 projects that involve YP with special needs (I.3.6.1). We continue to cooperate with NAs in SPI and TCA activities that prioritize this target group. The % share of KA2 submitted applications reaching minimum quality threshold for selection didn't reach the objective. The NA found the same situation in KA1 and KA3, however, the difference between the percentage reached and the goal set is completely residual. To improve the quality of submitted applications we will continue to provide support and carry the candidates. As to the % share of submitted final reports reaching minimum quality threshold without grant reduction based on quality grounds, the features continue to be very positive, with 97% of final reports reaching minimum quality (I.3.8.4). I.3.8.5 - Despite our efforts, this indicator was yet again not attained. The importance of submitting final reports within the 60-day deadline is always stressed during our beneficiary trainings and project owners monitor this deadline closely. We managed to reach 89% share of final reports with financial adjustments below 2%, not far from the 90% target set in WP2019.

3. An overview of the communication and information activities undertaken to promote the decentralised actions in the field of youth. Please specify any activities related to centralised actions. In 2019, 3 main strategies were applied:

- 1 Online promotion, dissemination of good practices and communication:
- 2 Strong approach to national media (Tv, Radio, and national newspapers);
- 3 Presential events all over the country in direct contact with youngsters. With an impressive number of project submissions in the last few years, the focus has changed and the PT NA targeted the young people, trying to reach them directly and with young people presenting their experience within Erasmus+.

More than 250 events in partnership with Eurodesk Portuguese Multipliers, all over the country, and with the participation of more than 40k youngsters, youth workers and politicians were delivered (results in other section). A part of this events was specifically for Erasmus+ Sports information and dissemination and centralised actions under Erasmus+, and also during the European Youth Week 2019. We were also present in the two biggest national youth fairs: Qualifica and Futuralia where we presented the program and disseminated Erasmus+ many opportunities.

In December we co-hosted, with the other National Agency Erasmus+ Education and Training, the Good Practices Ceremony

(https://www.youtube.com/watch?v=chzzEaGR4DU&list=PL9ISZ9jSdOLn-Ls5OnQY_iV8kwuDQ-SQy), where we rewarded the projects considered Good Practices in Youth as well as the projects considered inspirational. This video resources were afterwards delivered for youngsters, youth workers, stakeholders and beneficiaries were highly valued among the E+ community, and an important source of information to disseminate information and results.

For the International Volunteer Day, we celebrated with presentation of inspirational examples of volunteers to the press and to young people, with events managed all over the country by our Eurodesk multipliers and accredited organizations.

The European Elections were the trigger to launch a national campaign Promoting the participation of young people (first time voters as the targeted audience) in the European Elections. A major national campaign was delivered with impressive results.

In our channels we were, also, able to deliver 277 Facebook posts, 67 campaigns, 174 Instagram posts and stories, 12 newsletters (for an audience of +7k validated emails) and 43 websites news.

4. An overview of the activities in the field of youth to support and monitor beneficiaries as well as to improve the quality of project implementation (e.g. thematic monitoring and project management meetings). Any information provided in this section must not be repeated in section 7 "Horizontal actions and activities".

In 2019 the PT NA developed the following measures to support and monitor beneficiaries as well as to improve the quality of project implementation:

- a) Trainings for granted applications after each round that were done via webinar.
- b) monitoring visits the number of monitoring visits and regular meetings between NA staff and projects coordinators increased. This proximity contributes to minimize the risks of non-accomplishment of the projects;
- c) assignment of a project owner to each of the approved projects, responsible for following and supporting the activities and giving guidance to the beneficiaries in terms of project implementation.
 d) primary controls in line with what we proposed in our 2019WP and as has been our practice in the last years, we carried out more primary controls than the minimum number established by the Commission. Our purpose is to monitor and support as many projects as possible.
- e) Event "AgoraÉU" (Now EU) the PTNA organised an event for beneficiaries and potential beneficiaries where our mobile app europe4youth (an app that combines information and existing opportunities for youth in Europe in an organised way, with validated information structured in categories) was launched and also where working groups took place and organisations had the opportunity to talk to the PTNA officers and obtain relevant information of the Programmes.

- f) Accomplishment of the EVS evaluation and training cycle. The PT NA carried out 12 ON Arrival sessions, 9 Mid Term evaluation sessions, 1 Annual EVS Event and, 1 training for newly accredited organizations as well as an annual EVS accredited organizations.
- g) 27 webinars were carried out during 2019, to provide information and guidance on the Erasmus + and ESC and to update the beneficiaries on the rules and the changes to the Programmes. These webinars also included training sessions for evaluators, beneficiaries and Eurodesk multipliers.
- Through these actions, the quality of the projects has increased as well as the level of satisfaction of the beneficiaries. Proof of this, is the positive feedback that, each year, we received from the organisations and from other stakeholders in the youth field.
- 5. An overall qualitative assessment on the implementation of Erasmus+ actions in the field of youth (positive achievements, difficulties encountered, feedback received from programme stakeholders, overall judgement on the state of play) in linkage with the programme's objectives and priorities as well as with the youth policy context.

As we said before, The Erasmus + Programme is completely consolidated in Portugal.

During 2019 we continued to follow the Quality Management System for E+, implemented and certified in 2018, extending its scope to Eurodesk and ESC. The quality Management System in place documents processes, procedures and responsibilities for achieving quality objectives and improves the PTNA effectiveness and efficiency on a continuous basis.

Nevertheless, in each year and also in the previous year, the great imbalance between the n.º of submitted applications and the n.º of applications approved and granted continues to be a serious problem that potentially undermines our recipients' trust and, in extreme cases, culminates in frustration and distance from the participation values we intend to boost. The responsibility of assuring that the Programme and its opportunities reach all with quality imposes on us the search for a fair balance between the support to experienced organisations and the capacity to be open to the involvement of new organisations and territories. The Programme accomplished in its 6th year of implementation a percentage of about 41% of newcomers. The NA understands that the percentage of newcomers is quite high, since we are in the penultimate year of the Program. Even so, the PTNA is highly regarded by all the stakeholders and we notice a very low number of complaints, only one more than in 2018. We continue to focus on delivering the Programme's opportunities to target groups that are priority according to our objectives and priorities. We have been continuously increasing our efforts in reaching out to YPWFO specially from the interior regions of the country and in matching the projects with the priorities and main needs of the country's national youth policies. A set of measures and initiatives have been developed in recent years, contributing to the reduction of bureaucracy, allowing to overcome several obstacles and invest in the modernisation and internationalisation of youth organisations, especially regarding the recognition of qualifications and previous learning.

Considering the evaluation of final reports finalised in 2019 and comparing applications and their final results, we can say that these results were generally in line with the proposals approved.

The activities described in the applications were, in general, implemented during the projects despite some changes occurred but without compromising the quality of project implementation and the level of satisfaction of participants.

In terms of the topics covered in the projects, the analysis of the results of the final report shows us that the most addressed were:

- Inclusion
- youth (participation, youth work, youth policy;
- Creativity and culture
- EU Citizenship, EU awareness and Democracy;

In general terms, the assessment made by the beneficiaries (organisations and individuals) is positive and we always receive a good feedback from the communities and from the stakeholders involved

During 2019 the NA closed 10 KA2 projects, all of the type innovation, that were projects approved from 2016 and 2017. We are to conclude that, in most cases, all projects were executed according to the approved applications.

Therefore, the Programme's priorities and objectives were fulfilled, as clearly demonstrated by the final report's scorings (in-between 61.50 and 80 points).

The main priorities achieved were:

- Promoting entrepreneurship education and social entrepreneurship among young people (70% of the total).
- Promoting empowerment (60% of the total).
- Promoting empowerment, open to cross-sectorial cooperation, and active citizenship of young people and active citizenship of young people (40% of the total).

The projects produced tangible Intellectual Outputs as planned and we verified the implementation of the proposed activities through various monitoring actions carried out to completed projects.

The dissemination and exploitation of results was carried out as planned (including the Multipliers Events).

In general, we can reiterate that the expectations created by KA2 projects were fulfilled.

I.6.2.3. Key Action 3 (KA347)

According to the evaluation of final reports concluded in 2019, the results of finalised projects were in line with the expected results at the application stage. Generally, we can say that the objectives were reached and the activities planned were accomplished.

The most addressed topics were:

Reaching the policy dialogue/ dialogue with decision makers

Youth (Participation, Youth Policy)

Early School Leaving/combating failure in education

EU Citizenship/EU awareness

Labour Market issues incl guidance /youth unemployment

The majority of the projects finalised were all implemented at national and local level with impacts on communities, organisations and young people.

PT NA intends to highlight 2 Hosting Activities. 1st – EUROPEAN YOUTH WEEK 2019 at national level: we consider this activity as successful because the dynamics and events of the European Youth Week were a fundamental part of a strategy to raise awareness of the participation of young people in the European Elections 2019. The activity had a large impact and multiplying effect (183 events were held, with the participation of 19111 people, throughout the national territory). 2nd - "The Power of Non Formal Education" with the aim of improve the impact of Non Formal Education in empowering young people as real actors of the society. This TC had 447 applications and 31 participants, from 19 countries. PT NA consider this activity successful, as the number of applicants represent a large interest in the topic and objectives and gave a very rich diversity in terms of experiences, visions and practices, increasing the multiplying effect of the results and outcomes, that have been reached in a successful level.

PT NA ensured the monitoring and dissemination of learning outcomes through evaluations, data collection of results/achievements, DEOR, Ray studies, progress and final reports, compilation of learning outcomes, YouthPass, collecting and disseminating good practices, articles, news and other relevant documentation. To ensured the dissemination of activities PT NA used several methodologies: creating a mailing list; disseminating the results of TCA's in information events; using the results in another activity, through media news, website, social networks and partners tools. PT NA encouraged participants to use their learning outcomes, spread it and share it, in order to ensured the multiplier effect and dissemination. The results are used beyond the lifetime of activity, mainly to develop the quality of future activities, design strategies, becoming inspiring and creative tools for the development of new ideas and explore possibilities both in learning with mistakes and also in the use of success as an engine for

The Portuguese National agency has been consolidating national and international synergies:

- Cooperation with the National Federation of Youth Organization and Portuguese Youth Council.
- Municipalities, participating in bilateral initiatives between the NA and several Portuguese municipalities;
- Network of Eurodesk multipliers that had 2 network meetings and training:
- Cooperation with the Portuguese National Authority (Portuguese Youth Institute for Youth and Sports) with special involvement on the consultation process of the future programmes and participation in national youth initiatives promoted by them.
- "Europe goes Local. Strategic Partnership in the youth field supported by the Erasmus+ programme. The core aim of the project is to raise the quality of local youth work in particular through enhanced cooperation between various stakeholders;
- "Becoming a part of Europe" project. Similarly, within the Ray Network we produced important knowledge on the framework of this project. The main purpose of the project is to develop and share non-formal education methodologies and new inclusion practices, with a view to promoting the integration and social inclusion of refugees, asylum seekers and migrants and to foster understanding, tolerance and respect among people.
- cooperation with the other Erasmus + National Agency in Portugal jointed presence in seminars, activities to spread the programme opportunities, dissemination actions, the website, the cross-sectorial targets, the monitorization of common beneficiaries, the national event of good practices, an annual meeting to sheer information, etc.
- Representation of the European Commission in Portugal and its Europe Direct Information Centres.
- Also on the international context, during 2019, we developed important partnerships with Macedonia National Agency, with which we have signed an agreement of cooperation covering common areas of interest on the implementation of the programme. We also have developed a strong cooperation with the Norwegian National Agency with the realisation of a stud visit in Portugal.
- Representation on the coordination grupo of Agencies Network.
- Direction of the South Youth Network
- Stressing also important activities coordinated by our NA on the framework of the National Agencies Cooperation, namely the organization of the Value Fairs, a big event on Non Formal Education, and the Staff Training for Key Action 3.

I.7.2. Equity and inclusion

The Portuguese NA continues to prioritise and support inclusion, diversity and equity, as it has done in the last years. In 2019 the PT NA continued to implement Valorisation, Information, and Capacity Building measures in order to foster the participation of young people with fewer opportunities in the Programmes and increase the quality of inclusion projects.

- 1 -Valorisation: the PTNA continued to implement and communicate a valorisation system of projects that include YPWFO and evaluators were attentive to projects that reached out to disadvantaged groups.
 2 -Information: the PTNA focused on YP from rural/remote areas and in partnership with key stakeholders carried out information campaigns and trainings in these fields. YP and youth workers were informed of E+ and ESC opportunities and how these Programmes can be used as a tool to work with YPWFO and actively reach out to disadvantaged groups.
- 3 Capacity Building: the PTNA developed several capacity building activities for YP and youth workers:
- 3.1 CAIS Roadmap: CAIS works directly with migrants, refugees and YP at risk. We held information sessions on E+ and ESC opportunities with their street football project participants throughout our national territory.
- 3.2 -Sending participants to transnational activities that address these issues: TCA sending budget was allocated to activities that address these priority thematic areas to improve YP and youth workers' competences through international training, cooperation, and the exchange of good practice (e.g. activities designed for youth workers that work with YP with disabilities, NEETs etc.). Also, the PTNA sent participants to NET activities that addressed inclusion themes and focused on the programmes priority target groups and on human rights.
- 3.3 TCA Strategic Partnership On Inclusion (SPI): The PT NA is part of the TCA Strategic Partnership on Inclusion (SPI) since 2015 together with other NAs. In 2019 the PTNA involved 21 Portuguese youth workers in activities that focused on the inclusion of young people with fewer opportunities and the capacity building of the organisations they belonged to.
- 3.4 Becoming part of Europe BpE The PTNA continued to contribute to the general steering and management of the project and supported the conferences, workshops and clusters conducted by the partnership and sent participants to these activities.

3 - Presential events all over the country in direct contact with youngsters: We produced 2 types of flyers; On the other hand, promotion materials and a good practices booklet was also produced. We had a giant table game promoting and participating in events all around the country with updated information and promoting the participation of young peoples in Europe's life. We also participated in two 2 major youth fairs in Portugal (Qualifica and Futurália). The best practices ceremony (in partnership with Erasmus+ ET) was one of the biggest events of the year and a selection of best practices was disseminated

to the public in general. Celebrations of the Europe Day, International Youth Day, International Volunteer Day were delivered with success. Events in partnership with Europe Direct centres were delivered (Volta ao Emprego), as well as a presentation for the Portuguese Europe Direct centres in the Portuguese representation of the European Commission. Important links with Eurodesk, Youth Wiki and the Ray Network has been done resulting in activities and information disseminated to the public.

I.7.4. Evidence-based analysis of the outcomes/results of the programme

1. In 2019 PTNA was involved in several studies. We had started 2 new researches studies designated by RAY PART (approaches to participation and citizenship education and learning in Erasmus+ Youth in Action and in the European Solidarity Corps) and RAY SOC (analysis and monitoring of the European Solidarity Corps) and we had concluded 2 researches RAY CAP e RAY MON. The outcomes of finalised projects that we would like to stress are: RAY MON.

A better knowledge of the Programme and its implementation, the identification of its strengths and weaknesses, what works and what could be done better are all important data/features that should support informed decisions in order to do the necessary changes and reforms. In that sense, the NA used the trainings with beneficiaries' as well as the monitoring visits, not only to gather information but to disseminate knowledge on the results of the programme and the outcomes from the concluded studies.

All these data has been helpful to the management of the programme, supporting our decision process in several areas such as: training and information needs and quality assessment.

In order to verify the satisfaction levels of the beneficiaries of the National Agency Erasmus + Youth in Action, carry out a questionnaire / research a questionnaire answered by the beneficiaries of the program, use a quantitative methodology in order to obtain strategic and numerical results.

To use the data sent by e-mail to all beneficiaries in order to receive as many responses as possible, with all data being analysed statistically. The responses were performed using the Typeform platform.

In the survey, a 5-point Likert scale was applied, numbered from 1 to 5 in order to obtain a numerical index.

The results of the satisfaction surveys carried out in September 2019 to the beneficiaries of the National Agency Erasmus + Youth in Action, demonstrate a high level of satisfaction with the services provided, as a majority of the answers are in the positive quadrant.

The number of responses that were requested out of a total of 90 responses, a higher number than the year 2018 (81).

Furthermore 97% of requests, without reservation, recommend the services of the National Agency Erasmus + Youth in Action

II.1. Project lifecycle management

We followed and improved the practices that have being had good results on the previous years in terms of organization of the award decision.

In 2019 the PTNA had carry out an external expert training to update them on the revised Programme Guide and to assess the quality of their work, identify eventual needs or possibly increase or change the respective pool.

The NA used partially external evaluators in 2019 to assess the applications. The idea is to combine internal and external evaluators taking in account the number of applications.

In what concern assessment of final reports we, also, used external evaluators, according to the rules.

The Na provides applicants an beneficiaries with proper support along all the lifecycle of the project:

- At application phase we have in place a permanent helpdesk to help the applicants and organised regular infodays with several partners and specific webinars for the different actions of the programme.
 we give regular feedback on all the phases of the process: reception of the applications, eligibility criteria, Committee of Selection and final decision. We improved also the feedback to candidates related with the strong features of the applications and the improvement opportunities.
- we provide the organisation, with approved projects, with a "project owner", responsible of the support to the projects and that is always in contact with the promoters, clarifying eventual doubts, supporting on the necessary changes, mediating eventual conflicts with partners and participants and give support on all the technical issues, including the use of the IT platforms.
- the beneficiaries are asked to attend a series of group activities with the objective of support and helping to carry out the projects. Some of these activities are presential and web-based trainings for beneficiaries, good practices events, sector event (we start to organise this event with all the E+ and ESC stakeholders during 2019), thematic conferences and meetings, etc.
- we increased also the checks and implemented some monitorisation's visits based on risk.
- During the final report phase we always support the beneficiaries;
- In spite of not being compulsory the insertion of results on the Dissemination Platform for all the projects, we always encourage beneficiaries to use it, providing proport support through the project owner system.

There is no significant problems or derogations concerning the established rules.

II.2. Checks of grant beneficiaries

During the year 2019, the National Agency carried out the following primary checks for 2016, 2018 and 2019 Delegation Agreements. All primary checks procedures are updated in EplusLink.

Concerning the implementation of the Erasmus+ Programme, the NA performed thirty one primary checks, one Accreditation Monitoring and four Monitoring visit. The following should be mentioned: Regarding to 2016, the NA have been made nine primary checks. Eight desk checks, six in KA1, one in KA2 and one in KA3, risk based, and one On the Spot Check After, in KA2, was also carried out..

Concerning to 2018 the NA have been made seven primary checks.

KA1: three primary controls System Checks have been made to the Entities "Proatlântico", "SPIN", and "Psientífica" and one On the Spot Check During, risk based, were performed.

KA2: Desk Checks and On the Spot Check After weren't performed because all the projects are in follow up.

KA3: Desk Checks weren't performed too. One On Spot Check During, were realized.

The NA perform one monitoring visit to a beneficiary and we carried out a joint monitoring visit with Erasmus+ Education and Training to "AEVA - ASSOCIAÇÃO PARA A EDUCAÇÃO E VALORIZAÇÃO DA REGIÃO DE AVEIRO".

Referring to 2019 the NA have been made fifteen primary checks.

KA1: System Checks haven't been made to the Entities because only in 2020 it is possible like the Desk Checks. Ten On the Spot Check During were performed, 5 risk based, KA2: Desk Checks and On the Spot Check After weren't selected and made to the Entities because only in 2020 it's possible to do them, and the projects are still in the follow up status. Three On the Spot Check During were realized, 1 risk based. KA3: Desk Checks weren't selected and Two On Spot Check During were realized, one risk based.

As previously mentioned in 2019 one joint visit were made with the National Agency Erasmus+ Training and Education, in accordance with the annual Work Programme to "AEVA - ASSOCIAÇÃO PARA A EDUCAÇÃO E VALORIZAÇÃO DA REGIÃO DE AVEIRO".

II.3. Online Linguistic Support

During the assessment process we have carefully analysed the eligibility of the number of licenses requested. The process of allocation of OLS licenses itself did not experimented major difficulties.

The main focus was put on the mandatory assessment OLS licenses, with which we deal since the very beginning of the projects, during the contractualisation phase, including information on OLS on the first letter of granted projects and emphasizing the OLS support on the volunteering long-term projects, during the issue of the first documents, including the info-pack we send to all the projects.

During the project's life cycle we have a helpdesk to support organizations managing with the OLS issues and providing all the technical support. The major issues are related with the changing of the funding support for linguistic preparation into Online Linguistic Support, where applicable (after the OLS assessment, if the volunteers' needs match with the existent level of Portuguese Online Courses). We respond positively to each case presented by the beneficiaries and according to the applicable rules.

During 2019 we have received some complaints about the quality and attractivity of the OLS with some organisation suggesting that this support could be combined with some kind of presential support. The fact that the Portuguese Language Courses do not have the upper level also constitutes a problem for some volunteers and organisation.

The reason for this commitment level is due to the fact that 3° round projects are not considered since they were only had grant agreements signed in the beginning of the year 2020. When all grant agreements are awarded and signed in the beginning of the year 2020 the budget commitment rate will be 104,12%.

The budget realisation rate for 2015 is 95,05% per field which represents an improvement compared to DA2014. The budget realisation rate for 2016 is 93,58% per field being over 90%. Although our expectations were to attain a 100% realisation rate and despite all of our efforts this rate is the result of frequent and common changes to the projects (e.g. changes in the number of participants, real costs etc..) and 3 cancelled KA1 projects. The committed budget in KA113 and KA218 was not fully realised because we efficiently managed the respective budget which translated in lower costs.

In general, the results are in line with the predicted on the Work Programme. Most of the targets were reached an overcomed:

The % share of KA2 submitted applications reaching minimum quality threshold for selection didn't reach the objective. The NA found the same situation in KA1 and KA3, however, the difference between the percentage reached and the goal set is completely residual. To improve the quality of submitted applications we will continue to provide information and support and carry out trainings; We have seen in the last years that experienced organisations in the Programme tend not to comply with the 60-day final report submission deadline set out in the grant agreement, coincing on the extra 30 days given when receiving the reminder laid down in the NA Guide. We also note that newcomers to the Programme tend to submit the final reports on time. Despite our efforts, this indicator was yet again not attained. The importance of submitting final reports within the 60-day deadline is always stressed during our beneficiary trainings and project owners monitor this deadline closely. In 2019, although only 11% of the final beneficiary reports suffered a financial adjustment above 2% (I.3.8.6), not far from the 90% target set in WP2019. Nevertheless, this is more related to adjustments in the number of participants, distance bands and real costs that tend to be lower than the amounts requested at applications stage, than related to the quality of the projects that, as mentioned above, have an overall good score.

In 2019 Eurodesk Portugal maintained the network of 70 multipliers, covering the country. Also, close cooperation with EURES Network, EUROPE DIRECT Centres and Youth Wiki coordinator was constant during 2019. The 70 multipliers selected have had 2 network meetings and training, preparing and being involved in Voluntary campaign, and the Time to Move campaign. An agreement contract was signed by Eurodesk Portugal and each one of the multipliers. In terms of events, we highlight: 1 - Volunteering campaign - more than 200 events delivered in partnership with Eurodesk Portuguese Multipliers, all over the country, and with the participation of more than 30000 youngsters, youth workers and politicians. 2 - Time to move Campaign: More than 20 local/regional events and 1 national event for more than 500 participants; persons per event were involved; 3 - Participation in local and regional events all over the country - Eurodesk Road Show - with specific approaches depending on the target and the event; 4 - Participation in the "Volta ao Emprego" national route of events delivered by the Europe Direct centers in Portugal In terms of online strategy:

- 1 We delivered a monthly newsletter for the multipliers and for our database with relevant information and opportunities;
- 2 A facebook and Instagram were also permanent tools of information and dissemination;
- 3 Questions from the European Youth portal have been answered.
- 4 Webinars on different topics have been delivered with success.

The DiscoverEU campaign was also a great success, in terms of promotion, but also in terms of results, with over 2000 questions answered during 2019 related to this topic.

The results were impressive for Portugal, with 7707 applications from Portuguese youngsters and 884 ticket winners. The strategy in terms of Communication, information and dissemination for Eurodesk in Portugal was part of a coherent communication framework

In the previous year, the number of applications submitted under European Solidarity Corps Programme, was 145.

The average score of the projects approved was 72,50 points, wich we can say that is quite reasonable and the success rate was , also, quite acceptable - 67%.

In the third round of 2019 we approved the following projects: 55 Volunteering Projects, 9 Volunteering Partnerships, 2 Traineeships and Jobs and 31 Solidarity Projects.

Clearly, the most famous action was volunteering, also in line of previous years under Erasmus +Programme but for 2020 we will implement an action plan in order to try to attract more applications under the scope of jobs and traineeships.

Analyzing the objectives of the actions and priorities of the field addressed in the granted projects, we can notice that Inclusion were the leading objectives an topics addressed. Equality and non-discrimination and Community development ranks in second, followed by Climate action, environment and nature protection. Citizenship and democratic participation appear also with a significative number of projects and the following topics appear in lowest number: Skills development, Education and training, Culture and Youthwork.

The distribution of projects and the geographic distribution of participants (interior of the country, coastal areas and urban centres) is presented in the tables below:

In 2019, PT AN received applications from 85% of Portugal's regions, approving projects in 70% of the territory so we covered more than a half part of the country, who profs the success of the Programe in Portugal.

Also major national events and links to other stakeholders activities (EuropeDirect; Municipalities, etc) were part of our strategy to reach or target group. Celebrating the Volunteer Day – 5 Dec. – in Guimarães, we delivered the first ever Good Practices award ceremony, an important moment of promotion and celebration, with an event of celebration, with volunteers, Eurodesk Multipliers, our Secretary of State for Youth and Sports and ambassadors of the Programme for Portugal. Strong efforts to promote the new programme on national TV and media in general showed big success.

1.4. An overview of the activities to support and monitor European Solidarity Corps beneficiaries as well as to improve the quality of project implementation (e.g. thematic monitoring, kick-off and project management meetings).

Our experience shows us that the policies followed by PT NA, in what concerns to support and monitor projects and to assess implementation under Erasmus + Programme, produce good results so we replied them under European Solidarity Corps Programme.

So, in 2019, PT NA developed the following measures:

- a) Kick-off/project management meetings for the European Solidarity Corps project beneficiaries, in order to train organisations and project managers with the objective of implement high quality Projects;
- b) mandatory training for granted applications a training course that takes place 3 times a year, after the signature of the Conventions;
- c) monitoring visits the number of monitoring visits and regular meetings between NA staff and projects coordinators increased.
- d) assignment of a project owner to each of the approved projects individual projects were assigned to a Project Owner, who was responsible for following and supporting the activities and giving guidance to the beneficiaries in terms of project implementation:
- e) primary controls we carried out more primary controls than the minimum number established by the Commission.
- f) Inform and support beneficiaries on how to effectively organise the exploitation and dissemination of results, to foster the impact and visibility of the projects.
- g) Accomplishment of the volunteering training cycle on-arrival training and mid-term evaluation of European Solidarity Corps participants, to prepare them to engage on the activities having all the information and information needed and to evaluate projects and activities, namely on the mid-term evaluation. PT NA developed an annual training plan, with 11 ON Arrival sessions, 8 Mid Term evaluation sessions, 1 Annual Event and, also, an on-arrival training for new accredited organizations as well as an annual event to gather the views of the Portuguese volunteers, on how to improve their preparation and training and on how to enhance the monitoring of volunteer-sending organizations.
- g) regular webinars, during the year, to provide information and guidance on the ESC Programme, and to update the beneficiaries on the rules and the changes to the Programme.

These measures, together with the permanent availability of the Agency's technicians to respond, either by email or by phone, or in person to the questions posted by the beneficiaries and other stakeholders

1.5 Please provide a general overview of activities realised by your National Agency in order to foster projects/initiatives that promote the inclusion of disadvantaged target groups.

Since the Strategy on Inclusion is the same for both Programs - Erasmus+ and European Solidarity Corps we develop the same activities as mentioned bellow:

- 1 -Valorisation: the PTNA continued to implement and communicate a valorisation system of projects that include YPWFO and evaluators were attentive to projects that reached out to disadvantaged groups.
- 2 -Information: the PTNA focused on YP from rural/remote areas and in partnership with key stakeholders carried out information campaigns and trainings in these fields. YP and youth workers were informed of E+ and ESC opportunities and how these Programmes can be used as a tool to work with YPWFO and actively reach out to disadvantaged groups.
- 3 Capacity Building: the PTNA developed several capacity building activities for YP and youth workers:
- 3.1 CAIS Roadmap: CAIS works directly with migrants, refugees and YP at risk. We held information sessions on E+ and ESC opportunities with their street football project participants throughout our national territory.
- 3.2 -Sending participants to transnational activities that address these issues: TCA sending budget was allocated to activities that address these priority thematic areas to improve YP and youth workers' competences through international training, cooperation, and the exchange of good practice (e.g. activities designed for youth workers that work with YP with disabilities, NEETs etc.). Also, the PTNA sent participants to NET activities that addressed inclusion themes and focused on the programmes priority target groups and on human rights.
- 3.3 TCA Strategic Partnership On Inclusion (SPI): The PT NA is part of the TCA Strategic Partnership on Inclusion (SPI) since 2015 together with other NAs. In 2019 the PTNA involved 21 Portuguese youth workers in activities that focused on the inclusion of young people with fewer opportunities and the capacity building of the organisations they belonged to.
- 3.4 Becoming part of Europe BpE The PTNA continued to contribute to the general steering and management of the project and supported the conferences, workshops and clusters conducted by the partnership and sent participants to these activities.
- 1.6 An overall qualitative assessment on the implementation of European Solidarity Corps actions (such as positive achievements, difficulties encountered, feedback received from programme stakeholders, overall judgement on the state of play) in linkage with the programme's objectives as well as with the youth policy context.

Our core experienced beneficiaries were able understand and adapt their practice in accordance with European Solidarity Corps.

The implementation of the first two years shows that the values of the programme allowed us to reach different target groups on the social sector that have a strong tradition on the volunteering though at national level.

We have received a very positive feedback on the opportunities of the programme that is well demonstrated on the raising of application for Quality Level.

We can find strong links between European Solidarity Corps and the national youth policy context. Youth volunteering in Portugal is governed by Law no. 71/98, which provides the legal framework for volunteering in general and aims to promote and ensure all citizens the participation in volunteering activities.

However, we can also point out some difficulties concerning the implementation:

- Lack of knowledge about existing opportunities under ESC. Dissemination of volunteering activities are not reaching all target groups only those that are actively seeking opportunities to volunteer.
- It is hard for young people to gather and initiate a solidarity project on their own, without the support of an organisation. This may discourage young people from partaking in cross-border solidarity
- Lack of appeal for organisations to take in traineeships and/or jobs strands. The aforementioned strands are not attractive to organisations since they require a lot of funds and combinations of offers and services from other sources to be appealing.

Some of the appointed difficulties are now decreasing and we are sure that in 2020 the programme will be substantially implemented with stakeholders.

The implementation of the programme in Portugal is fully aligned with ESC objectives. The engagement of young people and organisations is really positive. Despite the small size of the country we continue to be part of the top countries with more registrations on the European Youth Portal, 5° place with almost 8000 registrations.

The programme has been an important contribute to strengthening cohesion, solidarity, democracy and citizenship in Europe.

The programme has been an important reinforcement on the capacity of the organisations, especially of the social sector, responding to societal challenges and strengthening communities, with particular effort to promote social inclusion.

1.7. An analysis of **finalised projects**. With the support of statistical data and other sources of information at your disposal, please provide information on European Solidarity Corps projects finalised in 2019 (and attach in Annex).

The rate of successfully finalised projects is in line with the practices of the Erasmus + Programme, without assignable difficulties with the qualitative and quantitative aspects of the projects. Results were generally in line with the proposals approved.

We have already 47 finalized project, 28 Solidary Projects and 19 volunteering projects and a big quantity on the closure phase.

The score of the final reports shows us that there is almost a correspondence between the quality of the applications and the quality of the implementation. 56% had a score between 71 an 90 point, 33% between 61 e 70, 2 projects between 91 and 100 and 2 projects between 51 e 60.

The activities described in the applications were, in general, implemented during the projects so we can say that the objectives were achieved.

In terms of the topics covered in the projects, the analysis of the results of the final report shows us that, also in line with those that are the objectives of the Programme, the most approached were:

- Climate action, environment and nature protection
- Community Development;
- Youth work, Rural development and urban regeneration, disaster prevention, culture and Inclusion.

In general terms, the assessment made by the beneficiaries (organisations and individuals) is positive and we always receive a good feedback from the communities and from the stakeholders.

We followed the same methods of Erasmus + in terms of organization of the award decision process with no significative issues concerning effectiveness of the process.

In 2019 the PTNA had carry out an external expert training to update them on the revised ESC + Guide and to assess the quality of their work, identify eventual needs or possibly increase or change the respective pool of experts.

The NA used partially external evaluators combined with internal evaluators.

Concerning the Award Committee, not having established yet as predicted in the national law is composition, we decided to organize it internally following the NA Guide's rules, in order to properly have the awarding decisions taken in due time.

Support along all the lifecycle of the project:

- permanent helpdesk to help the applicants and organised regular infodays with several partners and specific webinars for the different strands of the programme;

- regular feedback on all the phases of the process: reception of the applications, eligibility criteria, Committee of Selection and final decision. We improved also the feedback to candidates related with the strong features of the applications and the improvement opportunities:

- during the implementation of the projects we provide, to all the organisations with approved projects, with a "project owner", responsible of the support to the projects and that is always in contact with the promoters, clarifying eventual doubts, supporting on the necessary changes, mediating eventual conflicts with partners and participants and give support on all the technical issues;

- the beneficiaries are asked to attend a series of group activities with the objective of support and helping to carry out the projects. Some of these activities are presential and web-based trainings for beneficiaries, good practices events, sector event (we start to organise this event with all the E+ and ESC stakeholders during 2019), thematic conferences and meetings, etc.;

- we increased also the checks and implemented some monitorisation's visits based on risk;

- during the final report phase we always support the beneficiaries with the submission of the mobilities and reports, normally helping with the IT tools and clarifying doubts;

- in spite of not being compulsory the insertion of results on the Dissemination Platform, we always encourage beneficiaries to use it, providing support through the project owner system.

We didn't found any major problem or derrogations from the established rules.

Regarding the implementation of the European Solidarity Corps Program, the NA performed thirty five primary checks, included Quality Label Monitoring visits. The following should be mentioned:

Concerning to 2018 the NA have been made sixteen primary checks.

One System Checks have been made to the Entitie "SPIN", and five Quality Label Monitoring visits.

Ten On the Spot Check During were performed: three from ESC11, one risk based, three from ESC13, two risk based, two from ESC21, one risk based, and two from ESC31, one risk based.

Concerning to 2019 the NA have been made nineteen primary checks.

Four Quality Label Monitoring visits were performed and one joint monitoring visit with Erasmus+ Education and Training to "AMC - Aventura Marão Clube".

Fourteen On the Spot Check During were performed: nine from ESC11, five risk based, one from ESC13 and four from ESC31, two risk based.

As previously mentioned in 2019 one joint visit were made with the National Agency Erasmus+ Training and Education, in accordance with the annual Work Programme "to AMC - Aventura Marão Clube"

VII.2.3. Online Linguistic Support

During the assessment process we had carefully analysed the eligibility of the number of licenses requested. The process of allocation of OLS licenses itself did not experimented major difficulties.

The main focus was put on the mandatory assessment OLS licenses, with which we deal since the very beginning of the projects, during the contractualisation phase, including information on OLS on the first letter of granted projects and emphasizing the OLS support on the volunteering long-term projects, during the issue of the firts documents, including the info-pack we send to all the projects.

During the project's life cycle we have a helpdesk to support organizations managing with the OLS issues and providing all the technical support. The major issues are related with the changing of the funding support for linguistic preparation into Online Linguistic Support, where applicable (after the OLS assessment, if the volunteers' needs match with the existent level of Portuguese Online Courses). We respond positively to each case presented by the beneficiaries and according to the applicable rules.

During 2019 we have received some complaints about the quality and attractivity of the OLS with some organisation suggesting that this support could be combined with some kind of presential support.

The fact that the Portuguese Language Courses do not have the upper level also constitutes a problem for some volunteers and organisation.

In 2019 the PT NA request for transfer of funds has been accepted by the Commission and consists in transfer across key actions, from Traineeships and Jobs, Networking activities and STEC to Volunteering. The reasons for our proposal to allocation policy are the Plan to the implementation of Traineeships and Jobs during the tree years of the Programme, the analysing of number of submitted applications and number of applications rejected for lack of funding, the review of granted projects regarding to their number, budget awarded and execution, and last but not least, the management of expectations and motivation of candidates, our potential beneficiaries.

2. Please describe how the NA distributed the funds across the various selection rounds and between Volunteering Projects and Volunteering Partnerships.

According to the approved 2019 WP the PT NA distributed the funds for Volunteering across the various selection rounds in the following way R1 35%, R2 35% and R3 30%. The PT NA made some adjustments in our allocation policy. Our allocation policy was the PT 80% of Volunteering funds allocated to the Volunteering Projects and 20% of Volunteering funds allocated to Volunteering Partnerships. We assumed the deviation between the approved and the performed.

The realised grant allocation policy was PT 72% Volunteering funds allocated to the Volunteering Projects and 28% of Volunteering funds allocated to Volunteering Partnerships. The reasons are the number of submitted applications and number of granted projects regarding to their budget awarded.

3. With reference to the EPlusLink financial reports, please comment on the budget commitment level for 2018 and 2019 decentralised actions funds per action. If the budget commitment level was below 95% per action, please explain the reasons and describe the remedial actions.

The budget commitment rate for 2018 is 98,30% per action. According to the Epluslink financial reports the budget commitment rate per key action is around 100%. The budget commitment rate for 2019 is 64,08% per action. The reason for this commitment level is due to the fact that 3° round projects are not considered since the grant agreements were only issued in the beginning of the year 2020. When all grant agreements are awarded and signed in the beginning of the year 2020 the budget commitment rate will be 102,03%.

VII.2.6. Analysis of the programme management targets set in the 2019 NA Work Programme for the Corps

We overreached the targets related with number of participants in awarded project for Volunteering Placements (individual + team).

Concerning the occupational strand (traineeships and jobs) we did not reached the targets predicted. We have few projects for these last areas due some misunderstanding of the concept and lack of information in terms of legal regulation at national level of this action. In order to change this situation, in 2020 we will establish an action plan to try to attract more organisations to this particular action of the European Solidarity Corps.

In what concerns solidarity projects, the number of participants was slightly below the target.

The number of organization that have received the Quality Label for volunteering, exceed the set goal, 39. However, we did not reached the targets to QL of traineeships and Jobs — we only had 17 organisations that received QL for traineeships and we predicted 20; 13 organisations received QL for jobs and we predicted 15. The target is, however, very close and the reasons are the same we point out to the applications — the actions are not understood as a add value to the organisations and there are many doubts concerning their legal framework.

Concerning the % share of young people with fewer opportunities participating in Volunteering Placements, in Traineeships Placements and Jobs, we overreached the targets.

The share of applications reaching the minimum quality threshold (Volunteering; Traineeships and Jobs; Solidarity Projects) for selection exceeded the targets from 2019 WP.

Related with the % share of young people with fewer opportunities participating in Solidarity Projects we have no tools to access this target - it is not present on the applications and there is no tool that

enabling us to extract this indicator.

PT NA intends to highlight the hosting activity "Bridge to Solidarity PBA". This activity was a Partnership Building Activity (PBA) that aimed to increase knowledge about the European Solidarity Corps and to create a solid and trustable network of partners interesting in organizing ESC projects. The TC was delivered for 28 participants (youth workers, youth leaders, project managers and mainly newcomers/first applicants in the Erasmus+ Youth in Action Programme/ESC). Through the principles and practices of non-formal education and in an atmosphere where participants can learn and share from each other, "Bridge to Solidarity" wanted to open an intercultural dialogue and give space for the acquirement of new skills and the exchange of methods and experiences within the European Solidarity Corps. Looking at the results, the feedback of participants and reports, the objectives have been reached in a successful level.

PT NA ensured the monitoring and dissemination of learning outcomes through evaluations, data collection of results/achievements, Ray and final reports, compilation of learning outcomes, collecting and disseminating good practices, articles, news and other relevant documentation. To ensured the dissemination of activities PT NA use several methodologies: creating a mailing list; disseminating the results of Networking Activities in information events; through website, sociais networks and partners tools. PT NA encouraged participants to use their learning outcomes, spread it and share it, in order to ensured the multiplier effect and dissemination. The results are used beyond the lifetime of activity, mainly to develop the quality of future activities, design strategies, becoming inspiring and creative tools for the development of new ideas and explore possibilities both in learning with mistakes and also in the use of success as an engine for new challenges. Concerning the activities that were not carried out as planned initially, PT NA didn't realized some sending activities and 1 hosting activities due multiple reasons, between them: the hosting NA didn't implemented it, participants give up after the selection, lack of applicants, reformulation of strategies and Plans or PT NA didn't find participants with the profile.
